Charity Peal:

Attendance was talked about student success and indigenous; as a focus for next year,

Commencement is coming up soon, students have been committed to walk over the bridge recognizes their accomplishments.

How many of those students are in progress, are incomplete

Can this practice continue to be permitted, because we have a number of students who are in progress. Writing provincial exams, assessments are on their way in, still meeting requirement without results.

Will this practice continue.

Observation with students, but not graduate.

Students who are in a position, are eligible if they complete their course work. If there are specific cases, we will deal with those on a case by case situation.

Commencement is a recognition of the attempt to graduate. If you truly want to Graduate, have to wait until September.

Given all the other focusses surrounding graduation, some don't follow through.

Evaluations previously mentioned

Have a recommendation:

Evaluations on the upper level, who does evaluations on principals and at the board office?

Suggests - if there is going to be an evaluation done, you need to speak to the teachers, CUPE staff. How are issues that arise, and how are they handled.

Superintendent Rhodes:

Senior Staff does evaluations.

None have been done any yet. It is a wrap-around process

All Administrators will be evaluated by next year.

The Board is responsible is responsible for evaluating senior staff at the board office.

Rich Hotson:

Page 22 – Special Purpose and Other Grants

Orest this is really good clarity here.

Are there outstanding Purchase Orders, there will be some money spent?

They are priced out already.

Learning improvement fund – \$18,0000 left, just became aware of this last week, have an LST on extended leave, aware that a couple of student missing services, can we use this money for these students?

No. these funds are for CUPE.

Line 26 – NLG NLC enhancement fund, 54,000 was given, \$43,000 left, one time only, this is as I understand, to bring fluent elders into the school, See that it can be an excellent compliment to the courses.

Charity,

Regards to those funds those, there's an arbitrary steps, which may be kind of difficult, travel time is not incorporated into that amount, \$25 dollars is not the same as the person coming from Gingolx.

There is an issue of way the fund is being allocated.

No criteria that we have established.

Language and Culture Committee:

Is this asset goal for the committee?

Language and Culture Committee – not necessarily language and culture teachers, that's done in regular classrooms.

I trust there will be other things.

Confused, heard different things about the FNESC money, Clarify if it is for just language, or and culture.

FNESC is a language and culture grant – is open to both.

Language committee is there for:
Cultural vitalization
Curriculum in the schools
Trying to provide continuity
Want the them to learn advanced language

Need to put a motion to stop the \$25. It is administrative.

Superintendent Rhodes:

Look at the types of variety of approved projects, it is very clear that is not just language.

Rich Hotson

Line 27 – FNESC funds – have not got confirmation for it to roll over next year? No problem if not spent all this year.

Possibility that people can make contingency recommendations, that we can kick it into high gear.

Schools have submitted a plan, was not approved, a balance budget had to be re-submitted. Have to get FNESC approval.

Cautiously optimistic that they won't be asking for it back.

Teresa McMillan

Went to the Edge of Knife, a story done in Haida.

It a really powerful movie, amazing how you can use language and expand it in to a movie.

They had applied for the grant money, our schools got;

The grant was targeted to individual schools.

Charity

Gr 8 band performed at NLG executive meeting, the Secretary Treasurer mentioned there was specific money set aside to fund a band program. Could the district request access to the funds.

Orest: It was for a band teacher, not band.

We received no formal information.

Winnie

How we put in a proposal for the FNESC money, my plans for making traditional medicine, the kids are quite interested.

Plans to jar medicine. Would love to have the students in the smokehouse and learn how to ts'al. I find that they have an appreciation for it. Want to do it on a small scale in class, demonstrate, fill jars. Who do I contact?

Board Chair – each school has a committee, submit to them, they'll discuss approve or not approve.

Jackie: Good idea to get in those proposals, some were received and they were discussed.

Rich:

Acting Vice Principal position.

When the positions are posted, would there be consideration to have reps on the hiring committee?

Superintendent:

It still under discussion.

Mr. Maclean:

Came to the district in 2013, they started a program at the middle school in 2012, they received new instruments.

An agreement, with NLG to subsidize the wages at the middle school. Heard that our Sr staff went to NLG to request funds, but did not get anywhere.

That fund is there, is there some way we could liaise in that direction?

Board Chair:

Challenge you to get your students passionate again, the older grades. Our communities are looking for a large scale band.
