9.1 2018/2019 School Calendar Finalization

Superintendent Rhodes summarized feedback responses on the 2018-2019 School Calendar:

- Received 6 responses two from parents, said no
- Two employees write in clarying on how to do the Friday....
- Need to set up Pro D Days with NTU
- Executive recommending that there are number of family Fridays for elementary.
- At the District Student Advisory Committee meeting this afternoon, mixed reaction from the kids, feedback from peers, liked it, but didn't, some said not to do it on the Friday, maybe a Wednesday
- In regards to the longer blocks, unanimously they felt that was good. Would be beneficial.
- Did not get any phone calls, no emails. It's been silent, in terms of feedback.
- Attendance is a significant reason why for the change
- Make each day more important, Give the students......
- Increase length of classes, create opportunity for teachers to do things differently
- We need to try something, we can always go back to five days, if it does not work
- Creates white space, longer periods of time to encourage creativity
- Students can volunteer at the schools, their hours can be credited.
- The goal is to improve attendance. How can we accomplish this. Need to tamper with the current structure.

Trustee Barton:

K-8 – lot of concern for grade 8's missing out on their electives.

It was tried before, but didn't last long, parents were not happy.

Some kids say yes, they would like to stay home until grade 9

For the older ones, through the village government, they are supportive of the pilot program.

Parents that came out, were not pleased.

There are subs in the class months at a time, kids do not want to be there, there is no support.

Trustee Munroe:

Was unable to hold a consultation meeting due to many deaths in the Valley and was left with very little dates. But met with whoever was available.

Community events, cultural, deaths, left me with very few dates.

Did speak with a few people and heard:

This won't work, know a lot of people against it.

Asked if they would share their concerns, they said no.

Why so quick to have to decide. Some comments were bold. Option of Wednesdays, parents were very happy to hear that kids were finding ways to improve education.
