Nomination documents may be delivered by hand, mail email or other delivery service. **NO NOMINATIONS WILL BE ACCEPTED AFTER 4:00 P.M. FRIDAY, SEPTEMBER 11, 2026.**

QUALIFICATIONS: A person is qualified to be nominated, elected, and to hold office as a School Trustee if they meet the following criteria:

- Canadian citizen
- 18 years of age or older on general voting day **October 17, 2026**
- Resident of British Columbia for at least six months immediately before the day nominations are filed
- Not disqualified by the School Act or any other enactment from being nominated for, being elected to or holding office, or be otherwise disqualified by law

CAMPAIGN PERIOD EXPENSE LIMITS: In accordance with the Local Elections Campaign Financing Act, for the 2026 General Local Election, the following candidates expense limits during the campaign period to Trustee Electoral Areas 1, 2, 3, 4, and 5: **\$6,161.89**
